She also served as co-lead trial counsel in California's largest personal injury verdict, a historic \$58 million verdict for a man severely burned by a defective O-ring.

Ms. Spagnoli, by appointment of the Chief Justice of California, continues to serve on the Judicial Council of California's Civil Jury Instruction Committee (CACI) and has been a member of the CACI committee since 1997 and is its longest-serving member. She also serves as a member of the Los Angeles Judicial Selection Advisory Committee (JSAC) following her appointment in January 2020 by Governor Gavin Newsom. The influential committee reviews judicial candidates under consideration for nomination and appointment and provides essential feedback before forwarding their names to the Governor for review.
