This is one of the reasons why we are supporting SB 37. This bill seeks to strengthen oversight of attorney advertising by toughening advertising rules and closing enforcement gaps.

Additionally, we are seeking to eliminate the illegal practice of "capping" which occurs when a non-lawyer seeks out and sends a case to a particular lawyer or law firm for financial gain. I have heard from many members that this practice is going on and it must stop. We are seeking to strengthen the Rules of Professional Conduct with the State Bar, but we need all of us to speak to our colleagues. We need to police ourselves too. If you see or know something, you need to say something. There is an old saying "Just because you 'can' do something doesn't mean you 'should' do something."

Now is the time to police ourselves, and restore the honor and dignity to the plaintiffs' bar. If you are going to advertise, do it with the class and the honor that reflects well on our profession. Advertisements like "Uber/Lyft Accident? Get Millions" is not it!

We are fighting the fight of tort reform in Sacramento on a weekly if not daily basis. We are now fighting for the hearts and minds of the Legislature and the communities we represent. Out of control billboards and TV ads are going to make caps on damages, immunities and caps on attorney fees a reality. This will hurt your clients who are seeking justice and accountability.

Let's all come together and figure out the best way to recommit to seeking justice for consumers and reinforce our values on "why" we are plaintiffs' lawyers. We represent people who don't have a voice, who can't advocate for themselves, who can't afford a big expensive hourly law firm! Now is the time to double down on "why" you are a Consumer Lawyer!
