PIONEER SPIRIT Christine Spagnoli recites the grim toll: One Los Angeles police officer, paralyzed. Three U.S. Air Force officers, dead in Saudi Arabia. Two church members in Florida and two more in Sacramento — all killed because of design flaws in truck tires and large-capacity vans. Almost 20 years ago, Spagnoli spotted the patterns connecting these and other cases and has since devoted much of her practice to automotive product liability. She has won large verdicts and awards for her clients. More important, she has spurred changes that may have spared countless lives. Spagnoli's frequent adversary: The Ford Motor Co., maker of the E-350 15-passenger van, designed with a flaw that caused tire blowouts and rollover crashes that particularly deadly consequences. Spagnoli won a \$25.9 million verdict against Ford and a Florida church in 2018 over a crash that killed two. It's one of three E-350 cases she has taken to trial. 'I'm known as somebody who knows the history of the vehicle and has tried the cases against Ford. And juries have held them responsible.' Still, 'they keep crashing, and more people keep getting killed. Despite the fact that several juries have told them their conduct is reprehensible, they're not doing anything to take the vehicles off the road that are out there.''

TRAILS BLAZED Spagnoli began focusing on automobile liability early in her career, working on cases arising from fatal crashes in the Ford Explorer. Soon she spotted a trend that crashes involving a certain type of tire on certain kinds of vehicles. She alerted the National Highway Traffic Safety Administration, which issued a consumer advisory about the E-350 and ordered Goodyear to recall the tire. But not all van owners received notice of the hazard. One was a Sacramento church, which "kept driving the same van with the same tires on it." After two church members died in a crash, Spagnoli convinced a jury to award 550 million in punitive damages against Ford. Spagnoli's cases and others led Congress to mandate new safety standards for tires, and Ford and other companies have either stopped manufacturing the large vans or have made design changes to reduce the risk of rollovers.

**FUTURE EXPLORATIONS** As safety standards get tougher and designs improve, Spagnoli is happy to see fewer passenger-van cases these days. But as auto companies increasingly rely on new technologies in their vehicles, she expects a surge in litigation. Already, cases have been filed over the collision-avoidance technology installed in some cars, centering on why manufacturers put it in upscale models but not less expensive ones. Especially troubling to Spagnoli is the race to develop and distribute autonomous vehicles. "There still are no safety standards that allow any person to evaluate the performance of these vehicles. We're all going to be guinea pigs for the next 10, 15, 20 years until they iron out the glitches. And there will be glitches, no doubt about it."
